72-HOUR HEALTH GUARANTEE AGAINST DEATH DUE TO ILLNESS.
BUYERS MUST TAKE THE PUPPY TO THE VET WITHIN 72 HOURS OF RECEIVING THE PUPPY. A diagnosis of coccidiosis, giardia, parasites or any type of bacterial infection does not render your puppy unhealthy. Injury beyond seller's control is not guaranteed. Should death occur, **BUYER** will provide **SELLER** with a veterinarian statement stating the cause of death, to be examined by the **SELLER'S veterinarian**. If justifiable by both veterinarians, **SELLER** will then provide a replacement puppy if available or refund for the puppy's price. **THE \$300 SHIPPING FEE IS NON-REFUNDABLE. SELLER IS NOT RESPONSIBLE FOR ANY VETERINARIAN BILLS OR EXPENSES. Paypal and credit card services are also non-refundable.**

ONE-YEAR GUARANTEE AGAINST GENETIC DEFECTS THAT MAKE THE PUPPY UNSUITABLE FOR A "FAMILY PET"
Buyer understands that the following slight genetic defects are not considered serious or life threatening and therefore is not covered: **Umbilical Hernia, Inguinal Hernia, Cherry Eye, Undescended Testicles, Under Bite, Grade 1 or 2 patellas.** Buyer is responsible for shipping costs incurred for a replacement puppy in the case of genetic defect or **Buyer** may choose to keep puppy and accept all responsibilities. **Seller is not** responsible for shipping costs. **SELLER IS NOT RESPONSIBLE FOR ANY VET BILLS OR EXPENSES. A copy of a signed veterinarian check, as described above must be sent to the breeder within 10 days of delivery of this puppy. Transferring of ownership of this puppy for any reason renders this guarantee null and void.**

A copy of the shot record will be provided for you and your vet. IT IS VERY IMPORTANT THAT YOU FOLLOW THE SHOT REQUIREMENTS OF YOUR VET FOR YOUR PUPPY.

We encourage you to have your puppy spayed or neutered.

This written agreement is a binding contract in the State of Nebraska and is the entire agreement between the buyer and the seller concerning the health conditions or loss of this puppy. Any litigations shall take place in the state of Nebraska in Furnas County.
